18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
19

20 SECTION 1. Arkansas Code § 3-3-203 is amended to read as follows:

21 3-3-203. Purchase or possession by minor.

22 (a)(1) It shall be unlawful for any person under twenty-one (21) years
23 of age to purchase or have in his or her possession any intoxicating liquor,
24 wine, or beer.

25 (2) For the purposes of this section, intoxicating liquor, wine,
26 or beer in the body of a minor shall not be deemed to be in his or her
27 possession.

28 (b) It shall also be unlawful for ~~any~~ an adult to purchase on behalf
29 of a person under twenty-one (21) years of age any intoxicating liquor, wine,
30 or beer.

31 (c) ~~Any person~~ A person eighteen (18) years or age or older violating
32 this section is guilty of a violation and upon conviction shall be subject to
33 a fine of not less than one hundred dollars (\$100) nor more than five hundred
34 dollars (\$500).

35 (d) In addition to the penalties provided in this section, the trial
36 judge or magistrate may impose the following penalty or penalties or any



1 combination thereof:

2 (1) Require a person ~~under~~ eighteen (18) years of age or older
3 but under twenty-one (21) years of age to write themes or essays on
4 intoxicating liquors, wine, or beer; and

5 (2) Place a person ~~under~~ eighteen (18) years of age or older but
6 under twenty-one (21) years of age under probationary conditions as
7 determined by the court in its reasonable discretion designed as a reasonable
8 and suitable preventive and educational safeguard to prevent future
9 violations of this section by the person.

10 (e)(1) In addition to the fine authorized by subsection (c) of this
11 section, at the time of arrest of a person eighteen (18) years of age or
12 older for violation of the provisions of subsection (a) of this section, the
13 arrested person shall immediately surrender his or her license, permit, or
14 other evidence of driving privilege to the arresting law enforcement officer
15 as provided in § 5-65-402.

16 (2)(A) The Office of Driver Services or its designated official
17 shall suspend or revoke the driving privilege of the arrested person or shall
18 suspend any nonresident driving privilege of the arrested person, as provided
19 in § 5-65-402.

20 (B) The period of suspension or revocation shall be based
21 on the offense that caused the surrender of the arrested person's license,
22 permit, or other evidence of driving privilege as described in subdivision
23 (e)(1) of this section and the number of any previous offenses as follows:

24 (i) Suspension for sixty (60) days for a first
25 offense under subsection (a) of this section;

26 (ii) Suspension for one hundred twenty (120) days
27 for a second offense under subsection (a) of this section; and

28 (iii) Suspension for one (1) year for a third or
29 subsequent offense under subsection (a) of this section.

30 (3) In order to determine the number of previous offenses to
31 consider when suspending or revoking the arrested person's driving
32 privileges, the office shall consider as a previous offense any conviction
33 under subsection (a) of this section which occurred either prior to or after
34 the effective date of this subsection.

35 (f) A person less than eighteen (18) years of age who violates this
36 section is subject to § 9-27-301 et seq.

1
2 SECTION 2. Arkansas Code § 5-65-402(a)(1), concerning the age of a
3 person required to surrender of a license or permit to an arresting officer,
4 is amended to read as follows:

5 (a)(1)(A) At the time of arrest for violating § 3-3-203(a), § 5-27-
6 503(a)(3), § 5-65-103, § 5-65-205, § 5-65-303, § 5-65-310, § 27-23-114(a)(1),
7 § 27-23-114(a)(2), or § 27-23-114(a)(5), the arrested person shall
8 immediately surrender his or her license, permit, or other evidence of
9 driving privilege to the arresting law enforcement officer.

10 (B) The arresting law enforcement officer shall seize the
11 license, permit, or other evidence of driving privilege surrendered by the
12 arrested person or found on the arrested person during a search.

13 (C)(i) If a juvenile, as defined in § 9-27-301 et seq., is
14 arrested for violating § 3-3-203(a) or § 5-27-503(a)(3), the arresting
15 officer shall issue the juvenile a citation to appear for a juvenile intake
16 with a juvenile intake officer.

17 (ii) The arresting officer shall forward a copy of
18 the citation and the license, permit, or other evidence of the driving
19 privilege to the juvenile office before the scheduled juvenile intake.

20 (iii) Juveniles subject to the jurisdiction of the
21 circuit court under § 9-27-301 et seq., shall not be subject to this section,
22 except as provided in subsection (a)(1).

23
24 SECTION 3. Arkansas Code Title 5, Chapter 65, Subchapter 4, concerning
25 the surrender of a license or permit to an arresting officer, is amended to
26 add a new subsection to read as follows:

27 (i) Except as provided in subsection (a) of this section, this section
28 shall not apply to juveniles subject to § 9-27-301 et seq.

29
30 SECTION 4. Arkansas Code § 9-11-102 is amended to read as follows:
31 9-11-102. Minimum age – Parental consent.

32 (a) Every male who has arrived at the full age of seventeen (17) years
33 and every female who has arrived at the full age of sixteen (16) years shall
34 be capable in law of contracting marriage.

35 (b)(1) However, males and females under the age of eighteen (18) years
36 shall furnish the clerk, before the marriage license can be issued,

1 satisfactory evidence of the consent of the parent or parents or guardian to
2 the marriage.

3 (2)(A) The consent of both parents of each contracting party
4 shall be necessary before the marriage license can be issued by the clerk
5 unless the parents have been divorced and custody of the child has been
6 awarded to one (1) of the parents exclusive of the other, or unless the
7 custody of the child has been surrendered by one (1) of the parents through
8 abandonment or desertion, in which cases the consent of the parent who has
9 custody of the child shall be sufficient;

10 (B) The consent of the parent may be voided by the order
11 of a circuit court on a showing by clear and convincing evidence that:

12 (i) The parent is not fit to make decisions
13 concerning the child; and

14 (ii) The marriage is not in the child's best
15 interest.

16 (c) There shall be a waiting period of five (5) business days for any
17 marriage license issued under subsection (b)(2) of this section.

18 (d) If a child has a pending case in the circuit court, a parent who
19 files consent under subsection (b) of this section shall immediately notify
20 the circuit court, all parties, and attorneys to the pending case.

21
22 SECTION 5. Arkansas Code § 9-27-303 is amended to read as follows:

23 9-27-303. Definitions.

24 As used in this subchapter:

25 (1) "Abandoned infant" means a juvenile less than nine (9)
26 months of age whose parent, guardian, or custodian left the child alone or in
27 the possession of another person without identifying information or with an
28 expression of intent by words, actions, or omissions not to return for the
29 infant;

30 (2) ~~"Abandonment" means the failure of the parent to provide~~
31 ~~reasonable support and to maintain regular contact with the juvenile through~~
32 ~~statement or contact when the failure is accompanied by an intention on the~~
33 ~~part of the parent to permit the condition to continue for an indefinite~~
34 ~~period in the future and failure to support or maintain regular contact with~~
35 ~~the juvenile without just cause or an articulated intent to forego parental~~
36 ~~responsibility;~~

1 (A) Failure of the parent to provide reasonable support
2 and to maintain regular contact with a juvenile through statement or contact
3 when the failure is accompanied by an intention on the part of the parent to
4 permit the condition to continue for an indefinite period in the future and
5 support or maintain regular contact with a juvenile without just cause; or

6 (B) An articulated intent to forego parental
7 responsibility;

8 (3)(A) "Abuse" means any of the following acts or omissions by a
9 parent, guardian, custodian, foster parent, person eighteen (18) years of age
10 or older living in the home with a child, whether related or unrelated to the
11 child, or any person who is entrusted with the juvenile's care by a parent,
12 guardian, custodian, or foster parent, including, but not limited to, an
13 agent or employee of a public or private residential home, child care
14 facility, public or private school, or any person legally responsible for the
15 juvenile's welfare:

16 (i) Extreme or repeated cruelty to a juvenile;

17 (ii) Engaging in conduct creating a realistic and
18 serious threat of death, permanent or temporary disfigurement, or impairment
19 of any bodily organ;

20 (iii) Injury to a juvenile's intellectual,
21 emotional, or psychological development as evidenced by observable and
22 substantial impairment of the juvenile's ability to function within the
23 juvenile's normal range of performance and behavior;

24 (iv) Any injury that is at variance with the history
25 given;

26 (v) Any nonaccidental physical injury;

27 (vi) Any of the following intentional or knowing
28 acts, with physical injury and without justifiable cause:

29 (a) Throwing, kicking, burning, biting, or
30 cutting a child;

31 (b) Striking a child with a closed fist;

32 (c) Shaking a child; or

33 (d) Striking a child on the face; or

34 (vii) Any of the following intentional or knowing
35 acts, with or without physical injury:

36 (a) Striking a child six (6) years of age or

- 1 younger on the face or head;
- 2 (b) Shaking a child three (3) years of age or
- 3 younger;
- 4 (c) Interfering with a child's breathing;
- 5 (d) Urinating or defecating on a child;
- 6 (e) Pinching, biting, or striking a child in
- 7 the genital area;
- 8 (f) Tying a child to a fixed or heavy object
- 9 or binding or tying a child's limbs together;
- 10 (g) Giving a child or permitting a child to
- 11 consume or inhale a poisonous or noxious substance not prescribed by a
- 12 physician that has the capacity to interfere with normal physiological
- 13 functions;
- 14 (h) Giving a child or permitting a child to
- 15 consume or inhale a substance not prescribed by a physician that has the
- 16 capacity to alter the mood of the child, including, but not limited to, the
- 17 following:
 - 18 (1) Marijuana;
 - 19 (2) Alcohol, excluding alcohol given to
 - 20 a child during a recognized and established religious ceremony or service;
 - 21 (3) Narcotics; or
 - 22 (4) Over-the-counter drugs if a person
 - 23 purposely administers an overdose to a child or purposely gives an
 - 24 inappropriate over-the-counter drug to a child and the child is detrimentally
 - 25 impacted by the overdose or over-the-counter drug;
 - 26 (i) Exposing a child to chemicals that have
 - 27 the capacity to interfere with normal physiological functions, including, but
 - 28 not limited to, chemicals used or generated during the manufacturing of
 - 29 methamphetamine; or
 - 30 (j) Subjecting a child to Munchausen syndrome
 - 31 by proxy, also known as factitious illness by proxy, when reported and
 - 32 confirmed by medical personnel or a medical facility.
- 33 (B)(i) The list in subdivision (3)(A) of this section is
- 34 illustrative of unreasonable action and is not intended to be exclusive.
- 35 (ii) No unreasonable action shall be construed to
- 36 permit a finding of abuse without having established the elements of abuse.

- 1 (C) "Abuse" shall not include:
- 2 (i) Physical discipline of a child when it is
- 3 reasonable and moderate and is inflicted by a parent or guardian for purposes
- 4 of restraining or correcting the child; or
- 5 (ii) Instances when a child suffers transient pain
- 6 or minor temporary marks as the result of a reasonable restraint if:
- 7 (a) The person exercising the restraint is an
- 8 employee of an agency licensed or exempted from licensure under the Child
- 9 Welfare Agency Licensing Act, § 9-28-401 et seq.;
- 10 (b) The agency has policies and procedures
- 11 regarding restraints;
- 12 (c) No other alternative exists to control the
- 13 child except for a restraint;
- 14 (d) The child is in danger of hurting himself
- 15 or herself or others;
- 16 (e) The person exercising the restraint has
- 17 been trained in properly restraining children, de-escalation, and conflict
- 18 resolution techniques; ~~and~~
- 19 (f)(1) The restraint is for a reasonable
- 20 period of time; and
- 21 (2) The restraint is in conformity with
- 22 training and agency policy and procedures.
- 23 (iii) Reasonable and moderate physical discipline
- 24 inflicted by a parent or guardian shall not include any act that is likely to
- 25 cause and that does cause injury more serious than transient pain or minor
- 26 temporary marks.
- 27 (iv) The age, size, and condition of the child and
- 28 the location of the injury and the frequency or recurrence of injuries shall
- 29 be considered when determining whether the physical discipline is reasonable
- 30 or moderate;
- 31 (4) "Adjudication hearing" means a hearing to determine whether
- 32 the allegations in a petition are substantiated by the proof;
- 33 (5) "Adult sentence" means punishment authorized by the Arkansas
- 34 Criminal Code, § 5-1-101 et seq., subject to the limitations in § 9-27-507,
- 35 for the act or acts for which the juvenile was adjudicated delinquent as an
- 36 extended juvenile jurisdiction offender;

- 1 (6) "Aggravated circumstances" means:
- 2 (A) A child has been abandoned, chronically abused,
- 3 subjected to extreme or repeated cruelty, or sexually abused, or a
- 4 determination has been made by a judge that there is little likelihood that
- 5 services to the family will result in successful reunification; or
- 6 (B) A child has been removed from the custody of the
- 7 parent or guardian and placed in foster care or in the custody of another
- 8 person three (3) or more times in the last fifteen (15) months;
- 9 (7) "Attorney ad litem" means an attorney appointed to represent
- 10 the best interest of a juvenile;
- 11 (8) "Caretaker" means a parent, guardian, custodian, foster
- 12 parent, or any person ten (10) years of age or older who is entrusted with a
- 13 child's care by a parent, guardian, custodian, or foster parent, including,
- 14 but not limited to, an agent or employee of a public or private residential
- 15 home, child care facility, public or private school, or any person
- 16 responsible for a child's welfare;
- 17 (9) "Case plan" means a document setting forth the plan for
- 18 services for a juvenile and his or her family, as described in § 9-27-402;
- 19 (10)(A) "Cash assistance" means short-term financial assistance.
- 20 (B) "Cash assistance" does not include ~~long-term financial~~
- 21 ~~assistance or financial assistance that is the equivalent of the board~~
- 22 ~~payment or adoption subsidy;~~
- 23 (i) Long-term financial assistance or financial
- 24 assistance that is the equivalent of the board payment or adoption subsidy;
- 25 or
- 26 (ii) Financial assistance for car insurance.
- 27 (11) "Commitment" means an order of the court that places a
- 28 juvenile in the physical custody of the Division of Youth Services of the
- 29 Department of Human Services for placement in a youth services facility;
- 30 (12) "Court" means the juvenile division of circuit court;
- 31 (13) "Court-appointed special advocate" means a volunteer
- 32 appointed by the court to provide services to juveniles in dependency-neglect
- 33 proceedings;
- 34 (14) "Custodian" means a person other than a parent or legal
- 35 guardian who stands in loco parentis to the juvenile or a person, agency, or
- 36 institution to whom a court of competent jurisdiction has given custody of a

1 juvenile by court order;

2 (15) "Delinquent juvenile" means any juvenile:

3 (A) Ten (10) years old or older who has committed an act
4 other than a traffic offense or game and fish violation that, if the act had
5 been committed by an adult, would subject the adult to prosecution for a
6 felony, misdemeanor, or violation under the applicable criminal laws of this
7 state or who has violated § 5-73-119; or

8 (B) Any juvenile charged with capital murder, § 5-10-101,
9 or murder in the first degree, § 5-10-102, subject to extended juvenile
10 jurisdiction;

11 (16)(A) "Department" means the Department of Human Services and
12 its divisions and programs.

13 (B) Unless otherwise stated in this subchapter, any
14 reference to the department shall include all of its divisions and programs;

15 (17) "Dependent juvenile" means:

16 (A) A child of a parent who is in the custody of the
17 department;

18 (B)(i) A child whose parent or guardian is incarcerated
19 and the parent or guardian has no appropriate relative or friend willing or
20 able to provide care for the child;

21 (ii) If the reason for the incarceration is related
22 to the health, safety, or welfare of the child, the child is not a dependent
23 juvenile but may be dependent-neglected;

24 (C) A child whose parent or guardian is incapacitated,
25 whether temporarily or permanently, so that the parent or guardian cannot
26 provide care for the juvenile and the parent or guardian has no appropriate
27 relative or friend willing or able to provide care for the child;

28 (D) A child whose custodial parent dies and ~~no stand-by~~
29 ~~guardian exists~~ no appropriate relative or friend is willing or able to
30 provide care for the child;

31 (E) A child who is an infant relinquished to the custody
32 of the department for the sole purpose of adoption;

33 (F) A safe-haven baby, § 9-34-201 et seq.; or

34 (G) A child who has disrupted his or her adoption, and the
35 adoptive parents have exhausted resources available to them;

36 (18)(A) "Dependent-neglected juvenile" means any juvenile who is

1 at substantial risk of serious harm as a result of the following acts or
2 omissions to the juvenile, a sibling, or another juvenile:

3 (i) Abandonment;

4 (ii) Abuse;

5 (iii) Sexual abuse;

6 (iv) Sexual exploitation;

7 (v) Neglect;

8 (vi) Parental unfitness; or

9 (vii) Being present in a dwelling or structure

10 during the manufacturing of methamphetamine with the knowledge of his or her
11 parent, guardian, or custodian.

12 (B) "Dependent-neglected juvenile" includes dependent
13 juveniles;

14 (19) "Detention" means the temporary care of a juvenile in a
15 physically restricting facility other than a jail or lock-up used for the
16 detention of adults prior to an adjudication hearing for delinquency or
17 pending commitment pursuant to an adjudication of delinquency;

18 (20) "Detention hearing" means a hearing held to determine
19 whether a juvenile accused or adjudicated of committing a delinquent act or
20 acts should be released or held prior to adjudication or disposition;

21 (21) "Deviant sexual activity" means any act of sexual
22 gratification involving:

23 (A) Penetration, however slight, of the anus or mouth of
24 one (1) person by the penis of another person; or

25 (B) Penetration, however slight, of the labia majora or
26 anus of one (1) person by any body member or foreign instrument manipulated
27 by another person;

28 (22) "Disposition hearing" means a hearing held following an
29 adjudication hearing to determine what action will be taken in delinquency,
30 family in need of services, or dependency-neglect cases;

31 (23) "Extended juvenile jurisdiction offender" means a juvenile
32 designated to be subject to juvenile disposition and an adult sentence
33 imposed by the court;

34 (24) "Family in need of services" means any family whose
35 juvenile evidences behavior that includes, but is not limited to, the
36 following:

1 (A) Being habitually and without justification absent from
2 school while subject to compulsory school attendance;

3 (B) Being habitually disobedient to the reasonable and
4 lawful commands of his or her parent, guardian, or custodian; or

5 (C) Having absented himself or herself from the juvenile's
6 home without sufficient cause, permission, or justification;

7 (25)(A) "Family services" means relevant services provided to a
8 juvenile or his or her family, including, but not limited to:

9 (i) Child care;

10 (ii) Homemaker services;

11 (iii) Crisis counseling;

12 (iv) Cash assistance;

13 (v) Transportation;

14 (vi) Family therapy;

15 (vii) Physical, psychiatric, or psychological
16 evaluation;

17 (viii) Counseling; or

18 (ix) Treatment.

19 (B) Family services are provided in order to:

20 (i) Prevent a juvenile from being removed from a
21 parent, guardian, or custodian;

22 (ii) Reunite the juvenile with the parent, guardian,
23 or custodian from whom the juvenile has been removed; or

24 (iii) Implement a permanent plan of adoption,
25 guardianship, or rehabilitation of the juvenile;

26 (26) "Fast track" means that reunification services will not be
27 provided or will be terminated before twelve (12) months of services;

28 (27)(A) "Forcible compulsion" means physical force,
29 intimidation, or a threat, express or implied, of death, physical injury to,
30 rape, sexual abuse, or kidnapping of any person.

31 (B) If the act was committed against the will of the
32 juvenile, then "forcible compulsion" has been used.

33 (C) The age, developmental stage, and stature of the
34 victim and the relationship of the victim to the assailant, as well as the
35 threat of deprivation of affection, rights, and privileges from the victim by
36 the assailant shall be considered in weighing the sufficiency of the evidence

1 to prove compulsion;

2 (28) "Guardian" means any person, agency, or institution, as
3 defined by § 28-65-101 et seq., whom a court of competent jurisdiction has so
4 appointed;

5 (29)(A) "Home study" means a written report that is obtained
6 after an investigation of a home by the department or other appropriate
7 persons or agencies and that shall conform to regulations established by the
8 department.

9 (B)(i) An in-state home study, excluding the results of a
10 criminal records check, shall be completed and presented to the requesting
11 court within thirty (30) working days of the receipt of the request for the
12 home study.

13 (ii) The results of the criminal records check shall
14 be provided to the court as soon as they are received.

15 (C)(i) The person or agency conducting the home study
16 shall have the right to obtain a criminal background check on any person in
17 the household sixteen (16) years of age and older, including a fingerprint-
18 based check of national crime information databases.

19 (ii) Upon request, local law enforcement shall
20 provide the person or agency conducting the home study with criminal
21 background information on any person in the household sixteen (16) years of
22 age and older;

23 (30) "Indecent exposure" means the exposure by a person of the
24 person's sexual organs for the purpose of arousing or gratifying the sexual
25 desire of the person or any other person, under circumstances in which the
26 person knows the conduct is likely to cause affront or alarm;

27 (31) "Independence" means ~~that:~~

28 ~~(A)(i) A permanency planning hearing disposition for the~~
29 ~~juvenile who will not be reunited with his or her family because another~~
30 ~~permanent plan is not available; and~~

31 ~~(ii) A compelling reason exists why termination of~~
32 ~~parental rights is not in the juvenile's best interest; or~~

33 ~~(B) The juvenile is being cared for by a relative and~~
34 ~~termination of parental rights is not in the best interest of the juvenile a~~
35 permanency planning hearing disposition known as Another Planned Permanent
36 Living Arrangement (APPLA) for the juvenile who will not be reunited with his

1 or her family and because another permanent plan is not in the juvenile's
2 best interest;

3 (32) "Juvenile" means an individual who is:

4 (A) From birth to eighteen (18) years of age, whether
5 married or single; or

6 (B) Adjudicated delinquent, a juvenile member of a family
7 in need of services, or dependent or dependent-neglected by the juvenile
8 division of circuit court prior to eighteen (18) years of age and for whom
9 the juvenile division of circuit court retains jurisdiction;

10 (33) "Juvenile detention facility" means any facility for the
11 temporary care of juveniles alleged to be delinquent, or adjudicated
12 delinquent and awaiting disposition, who require secure custody in a
13 physically restricting facility designed and operated with all entrances and
14 exits under the exclusive control of the facility's staff, so that a juvenile
15 may not leave the facility unsupervised or without permission;

16 (34) "Law enforcement officer" means any public servant vested
17 by law with a duty to maintain public order or to make arrests for offenses;

18 (35) "Miranda rights" means the requirement set out in *Miranda*
19 *v. Arizona*, 384 U.S. 436 (1966), for law enforcement officers to clearly
20 inform an accused, including a juvenile taken into custody for a delinquent
21 act or a criminal offense, that the juvenile has the right to remain silent,
22 that anything the juvenile says will be used against him or her in court,
23 that the juvenile has the right to consult with a lawyer and to have the
24 lawyer with him or her during interrogation, and that, if the juvenile is
25 indigent, a lawyer will be appointed to represent him or her;

26 (36)(A) "Neglect" means those acts or omissions of a parent,
27 guardian, custodian, foster parent, or any person who is entrusted with the
28 juvenile's care by a parent, custodian, guardian, or foster parent,
29 including, but not limited to, an agent or employee of a public or private
30 residential home, child care facility, public or private school, or any
31 person legally responsible under state law for the juvenile's welfare, that
32 constitute:

33 (i) Failure or refusal to prevent the abuse of the
34 juvenile when the person knows or has reasonable cause to know the juvenile
35 is or has been abused;

36 (ii) Failure or refusal to provide the necessary

1 food, clothing, shelter, and education required by law, excluding failure to
2 follow an individualized education program, or medical treatment necessary
3 for the juvenile's well-being, except when the failure or refusal is caused
4 primarily by the financial inability of the person legally responsible and no
5 services for relief have been offered;

6 (iii) Failure to take reasonable action to protect
7 the juvenile from abandonment, abuse, sexual abuse, sexual exploitation,
8 neglect, or parental unfitness when the existence of this condition was known
9 or should have been known;

10 (iv) Failure or irremediable inability to provide
11 for the essential and necessary physical, mental, or emotional needs of the

19 SECTION 34. EMERGENCY CLAUSE.

20 It is found and determined by the General Assembly of the State of
21 Arkansas that laws concerning juveniles need to be amended and updated; that
22 the fair and efficient administration of juvenile law is highly important to
23 society at large; and that this act is immediately necessary because the
24 judiciary needs to begin addressing these changes in laws involving
25 juveniles. Therefore, an emergency is declared to exist and this act being
26 immediately necessary for the preservation of the public peace, health, and
27 safety shall become effective on:

28 (1) The date of its approval by the Governor;

29 (2) If the bill is neither approved nor vetoed by the Governor,
30 the expiration of the period of time during which the Governor may veto the
31 bill; or

32 (3) If the bill is vetoed by the Governor and the veto is
33 overridden, the date the last house overrides the veto.
